C. on the eastern side of Marlboro Drive, and being known and designated as Lot No. 259 of Belle Meade, Section 3, as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "GG", at Page 187, said lot fronting 80 feet on the eastern side of Marlboro Drive and running back in parallel lines to a depth of 140 feet on the North and South sides and being 80 feet across the rear.
