All that certain piece, parcel or tract of land, situate, lying and being in Paris Mountain Township, County of Greenville, State of South Carolina, containing 4.21 acres, more or less, lying between Farr's Bridge Road and the White Horse Road, and having according to a plat of property of Berea Methodist Church, prepared by Pickell and Pickell, Engineers, September 8, 1953, the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of Farr's Bridge Road at the Southwest corner of property of T. W. Freeman and running thence along said property, N. 66-47 E. 193.2 feet to an iron pin; thence continuing along said property, S. 85-46 E. 489 feet to an iron pin on the West side of the White Horse Road; thence along the West side of said road, S. 11-55 W. 315.4 feet to an iron pin at the Northeast corner of property of W. A. Taylor; thence with the line of said Taylor property, N. 86-30 W. 519.9 feet to an iron pin on the East side of Farr's Bridge Road; thence along the edge of said road, N. 18-53 W. 250.1 feet to beginning point.

The plat describing the aforesaid tract of 4.21 acres is recorded in the R.M.C. office for Greenville County in Plat Book DD, at page 202.

And it is hereby agreed that the said Postponement of Lien shall have the same force and effect as if the above-in-part recited Mortgage, or Mortgages, in favor of **Division of National Missions of the Board of Missions of The Methodist Church** had been entered upon the records in the office for the recording of Deeds, etc., of Greenville County aforesaid, on a day subsequent to the day of entry for record in the office, aforesaid of the said Mortgage for the sum of FORTY-SEVEN THOUSAND FIVE HUNDRED Dollars.
