William K. Hightower, and Frances P. Hightower, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Four Thousand Five Hundred and No/100 ----- DOLLARS (\$ 4,500.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Chick Springs Township, on the Southwestern side of the County Road leading from Cross Roads School to Greenville, also known as the Rainey Road, bounded by lands now or formerly of J. H. Rainey and J. T. Rainey, containing one acre, more or less, and being more particularly described as follows:

BEGINNING at a nail and cap in the center line of the above mentioned Road on the J. T. Rainey line, and running thence with the center line of said Road, N. 26-14 W. 200 feet to a nail and cap; thence S. 46-50 W. over an iron pin on the bank of Road, 240.2 feet to an iron pin; thence S. 26-14 E. 200 feet to an iron pin, corner of the J. T. Rainey line; thence N. 46-50 E. 240.2 feet to the beginning corner.
