I, Beulah N. Jones, of Greenville County, S. C., SEND GREETING:

Whereas, I, the said Beulah N. Jones,  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to John A. Park,  
in the full and just sum of FIVE HUNDRED and no/100 (\$500.00) DOLLARS,

, to be paid as follows: Two Hundred Fifty (\$250.00) Dol-  
lars on January 12, 1959; and Two Hundred Fifty (\$250.00) Dollars on  
July 12, 1959; until paid in full,

, with interest thereon from date  
at the rate of Six per centum per annum, to be computed and paid semi-annually  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises

Summitt Street), and Parker Road, and described as follows:

BEGINNING at a stake 150 feet northerly from Montana Street,  
(formerly Summitt Street), on western side of Hollis Street, and running  
thence N. 89 1/2 W. 125 feet, more or less, to stake; thence N.-30 E. 50  
feet to stake; thence S. 89 1/2 E. 125 feet, more or less, to stake on said  
Hollis Street; thence with the western side of Hollis Street, S.-30 W. 50  
feet to the point of beginning; being shown and designated as Lot No.
