of Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

C., said lot having a frontage of 60 feet on the southwest side of Hale Drive, a depth of 145.3 feet on the north side, a depth of 144.6 feet on the south side, and a rear width of 60 feet.
