NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being near the City of Travelers Rest, in the County of Greenville, State of South Carolina, being known and designated as property of Pickens W. Wyatt and Etrulia R. Wyatt, plat of which is recorded in the RMC Office for Greenville County in Plat Book NN, page 144, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeasterly side of Henderson Road joint corner with Travelers Rest School property and running thence along Henderson Road N. 41-30 E. 357.9 feet to an iron pin; thence S. 38-42 E. 150 feet to an iron pin in the line of the Love Estate property; thence along the line of the Love Estate property S. 41-36 W. 153.8 feet to an iron pin; thence along the line of the Travelers Rest School property S. 81-06 W. 231.7 feet to an iron pin, the point of beginning.
