SEND GREETING:

Whereas, I, the said Katie Anderson

(2,158.04)- - - ; to be paid \$40.00 per month for 35 months, all to be  
due and paid in full in 36 months from date hereof--

with interest thereon from maturity  
at the rate of <sup>7%</sup> seven percentum per annum, to be computed and paid annually from maturity  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
