C., in the full and just sum of Eight Hundred Twenty-six and 81/100 - - - - - (\$ 826.81) Dollars, with interest from the date hereof at the rate of, seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, lying just across the road from Gum Springs Pentacostal Church, on the northern side of the Few's Bridge Road, being bounded on the North and West by lands of J. A. Stewart, Sr., on the East by lands of Lena Barton and on the South by the said Church lot and other lands of J. A. Stewart, Sr., and being the same lot of land conveyed to me by my father, J. A. Stewart, Sr., having the following courses and distances, to wit:-
