To All Whom These Presents May Concern

I, Roachel D. Lynn,

hereinafter spoken of as the Mortgagor send greeting.

Whereas I, Roachel D. Lynn,

is justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of Ten Thousand Four Hundred and No/100 - - - - - Dollars

(\$ 10,400.00), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by that one certain note or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of Ten Thousand Four Hundred and No/100 - - - - - Dollars (\$ 10,400.00)

with interest thereon from the date hereof at the rate of 5 1/2 per centum per annum, said interest to be paid on the 10 day of October 1958 and thereafter said interest and principal sum to be paid in installments as follows: Beginning on the first day of October 1958, and on the first day of each month thereafter the sum of \$ 63.96 to be applied on the interest and principal of said note, said payments to continue up to and including the first day of August 1983, and the balance of said principal sum to be due and payable on the first day of September 1983; the aforesaid monthly payments of \$ 63.96 each are to be applied first to interest at the rate of 5 1/2 per centum per annum on the principal sum of \$ 10,400.00 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

Now, Know All Men, that the said Mortgagor in consideration of the said debt and sum of money mentioned in the condition of the said note and for the better securing the payment of the said sum of money mentioned in the condition of the said note with the interest thereon, and also for and in consideration of the sum of One Dollar in hand paid by the said Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold, conveyed and released and by these presents does grant, bargain, sell, convey and release unto the said Mortgagee and to its successors, legal representatives and assigns, for even, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being

on the Western side of Azalea Circle, near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as a portion of Lot No. 8, Section 2 of a subdivision known as North Gardens, plat of which is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book EE, at page 103 and, according to a later plat by T. C. Adams, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Azalea Circle at the joint front corner of Lots Nos. 9 and 8, Section 2, which iron pin is 150 feet north of the intersection of Azalea Circle and North Garden Circle; running thence along the joint line of Lots Nos. 9 and 8, Section 2, N. 79-0 W. 160 feet to an iron pin; running thence N. 11-0 E. 25.8 feet to an iron pin; running thence N. 76-22 W. 121.8 feet to an iron pin; running thence along a new line, N. 12-43 E. 64.7 feet to an iron pin in the lot line of Lot No. 7, Section 2; running thence along the line of Lot No. 7, Section 2, S. 79-0 E. 283.5 feet to an iron pin on the Western side of Azalea Circle; running thence along the Western side of Azalea Circle, S. 11-0 W. 85 feet to an iron pin, the point of beginning.
