TO ALL WHOM THESE PRESENTS MAY CONCERN: **I, Clarence Evans Nichols,**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Twenty-one Hundred -----

DOLLARS (\$ 2100.00), with interest thereon from date at the rate of **Six (6%)**

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chisk Springs Township, about three miles southward from Greer, known as the old R.L. Johnson home place, on branch waters of the Enoree River and near the Bibbs Shoals Road, bounded by lands now or formerly of Whit Smith on the north east and south by lands of T.R. Childress, and southwest by the Walker Elmore lands, and northwest by Mrs. Cora Hiott lands, having courses and distances according to plat by H.S. Brockman, Surveyor, dated September 28, 1936, as follows;

BEGINNING at an iron pin by a large pine, corner with Boiter and Elmore lands, and running thence N. 15-30 W. 834 feet to a stone on or near branch; thence N. 35-37 E. 1304 feet to a water oak 3x; thence S. 30 E. 285.5 feet to an iron pin; thence N. 74-45 E. 693 feet to an iron pin; thence S. 31-30 E. 81 feet to a stone; thence S. 38-40 W. 2223 feet to the beginning corner. containing 27.29 acres, more or less.

This is the same property conveyed to Clarence Evans Nichols by deed of J.E. McCall, recorded in Deed Book 303, page 183, R.M.C. Office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
