

Company; thence with line of last mentioned property S. 67-32 E. 41 feet to iron pin, corner of lot heretofore conveyed by Betty Whitmire to Smith Grain Company; thence with line of said lot S. 22-52 W. 129.7 feet to iron pin on Broad Street; thence with Broad Street N. 66-48 W. 41 feet to beginning corner.
