BEGINNING at an iron pin on the northern side of Welcome Avenue, at a point located 8 feet southwest of the joint front corner of Lots Nos. 1 and 2 as shown on the above mentioned plat recorded in Plat Book PP, at Page 123, and running thence through Lot No. 1 according to said plat, N. 20-26 E. 60 feet, more or less, to a point in the joint line of Lots Nos. 1 and 2; thence with the joint line of said lots, S. 25-17 E. 55 feet, more or less, to an iron pin on the northern side of Welcome Avenue, joint front corner of Lots Nos. 1 and 2; thence with the northern side of Welcome Avenue, S. 59-30 W. 8 feet to the beginning corner.
