W, S. Coates, Jr. of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of South Carolina, a corporation, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Two Hundred Fifty Dollars (\$ 11,250.00), with interest from date at the rate of Five & One-Fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-Seven and 50/100----- Dollars (\$ 67.50), commencing on the first day of November, 19 58, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of October, 19 83.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the eastern side of Watson Road near the City of Greenville, being shown as lot # 93 of Block B, on a plat of Section 2 of Orchard Acres, recorded in Plat Book BB, at Page 103, and described as follows:

BEGINNING at a stake on the eastern side of Watson Road 125 feet North from Ridge Spring Road at the corner of lot # 92 and running thence with the eastern side of said road, N. 9-58 W. 110 feet to an iron pin at the corner of lot # 94; thence with the line of said lot, N. 80-02 E. 206 feet to an iron pin; thence S. 8-27 E. 65 feet to an iron pin; thence S. 40-32 W. 70.3 feet to an iron pin at the corner of lot # 92; thence with the line of said lot, S. 80-02 W. 150 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed of James D. Phillips and Ella M. Phillips to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
