(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100-----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

In Butler Township, near Rocky Creek Baptist Church, lying on the East side of a road which leads from Roper Mountain Road to Bennett's Bridge Road, at or near Rocky Creek Baptist Church, and described as follows:

BEGINNING at an iron pin in the Eastern ditch of the above mentioned road, said pin being 1460 feet from the northwest corner of lands of O. H. Bagwell and lands of Jones; thence S. 24-57 E. 536 feet to iron pin on the Cecil Bouchillon line; thence N. 65-07 E. 322 feet to iron pin; thence N. 55-57 W. 625 feet to the beginning corner, containing 2 acres, more or less.
