SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand Five Hundred and no/100-----

DOLLARS (\$3,500.00), with interest thereon from date at the rate of Six (6%)

per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns

those pieces, parcels or lots

All ~~that piece, parcel or lot~~ of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 19, 20, 21 and 22, as shown on a plat prepared by Dalton & Neves, dated June, 1931, entitled "East Lynne", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book H at page 195, and having according to said plat, when described in the aggregate, the following metes and bounds:

BEGINNING at an iron pin on the northwestern side of Lindsay Avenue at the joint front corner of Lots Nos. 18 and 19, and running thence with the line of Lot No. 18, N. 55-45 W. 258.1 feet to an iron pin in the rear line of Lot No. 24; thence with the line of Lots Nos. 24 and 25, N. 35-06 E. 96.5 feet to an iron pin at the joint corner of Lots Nos. 22, 25 and 26; thence with the rear line of Lot No. 26, N. 81-02 E. 12.4 feet to an iron pin at the joint corner of Lots Nos. 14, 22 and 26; thence with the line of Lot No. 14, S. 55-45 E. 249.4 feet to an iron pin on the northwestern side of Lindsay Avenue; thence with the northwestern side of Lindsay Avenue, S. 35-06 W. 105 feet to the point of beginning.
