I, MYRTLE W. BANKS

SEND GREETING:

Whereas, I, the said Myrtle W. Banks

hereinafter called the mortgagor(s)

in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to PEOPLES NATIONAL BANK OF GREENVILLE, SOUTH CAROLINA

hereinafter called the mortgagee(s), in the full and just sum of Twenty-five Hundred and no/100 ----- DOLLARS (\$ 2500.00), to be paid

\$180.00 on the 15 day of January, 1959; \$180.00 on the 15 day of April, 1959; \$180.00 on the 15th day of July, 1959; and \$180.00 on the 15 day of October, 1959; and a like amount of \$180.00 on the 15th day of each January, April, July and October thereafter until the entire principal sum is paid in full; with the right of mortgagor to pay any portion or all of said indebtedness on any regular payment date after one year from date without penalty

, with interest thereon from date

at the rate of six (6%) percentum per annum, to be computed and paid

quarterly in addition to principal until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Chick Springs Township, Greenville, County, State of South Carolina, being known and designated as Lot No. 7, according to plat of property of Robert J. Edwards, made by Dalton & Neves, Engineers, June 1939, and being more particularly described as follows:

BEGINNING at a stake on the west side of Artillery Road, which stake is 700 feet south of the southwest corner of Warehouse Court and Artillery Road and running thence with Lot No. 8, S. 59-30 W. 300 feet to a stake in line of other Edwards property; thence N. 30-30 W. 100 feet to a stake in the line of Lot No. 6, N. 59-30 E. 300 feet to a stake on Artillery Road; thence with said road, S. 30-30 E. 100 feet to the beginning corner.
