C. and being known and designated as Lot No. 25 of Roland Heights as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "S" at page 34; said lot fronting 80 feet on the southeast side of Alice Avenue and running back in parallel lines to a depth of 175 feet on both sides, and being 80 feet across the rear.
