, with interest thereon from date

at the rate of Six per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Highway #25 and containing 10.50 acres, more or less, according to plat of property of W. C. Adams prepared by W. J. Riddle, surveyor, March 1948 and recorded in the R. M. C. Office for Greenville County in Plat Book "U", at Page 23 and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the western side of U. S. Highway #25 and running thence S. 85-10W. 1017 feet to an iron pin; thence N. 9-50 W. 386 feet to a pin at Branch; thence up the Branch and along the meanders thereof, the following courses and distances: N. 78-30 E. 210 feet; N. 85-30 E. 71.5 feet; N. 75-00 E. 204 feet; N. 66-40 E. 205 feet; S. 78-30 E. 162 feet; N. 72-00 E. 178.5 feet to a stake on the western side of U. S. Highway #25; thence along the western side of said Highway S. 9-50 E. 505.5 feet to the point of beginning.
