"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being known and designated as Lots Nos. 70 and 71 of Avalon Estates as shown on plat recorded in the R. BEGINNING at an iron pin on the west side of the Buncombe Road U. S. Highway 25, joint front corner of Lots Nos. 69 and 70; thence with the line of said lots S. 82-53 W. 225 feet to an iron pin; thence N. 7-07 W. 100 feet to an iron pin in line of Lot No. 72; thence with the line of said lot N. 82-53 E. 225 feet to an iron pin on the Buncombe Road; thence with said road S. 7-07 E. 100 feet to the beginning.
