Conveyors and green chain; dry-kiln piping, track & trucks; dust collecting system; piping, collector & fan; electric power installation, conductors, poles, transformers; glue room equipment: presses and clamps; Grinders: 2 bench, 2 saw, 1 knife and one head grinder; 3 jointers; lumber carts; machine shop: 1 14"x6' Lathe, 24" drill press, Atlas Milling machine, arbor press, electric and gas welding equipment; Office equipment: 2 cash registers, 2 adding machines, 2 calculators, intercom. system, stoves, visible inventory files, time clocks; Power plant: boiler with piping, steam engine and electric motors together with lineshafts and belting; Planers: 3 single surfacers, 2 moulders and planer-matcher; Sash and door Millwork machinery: 1 drum sander, 2 drill presses, shutter groover, 1 shaper, 2 stickers, 2 tenoners, chain mortiser, frame machine, sash relishers and routers; Saws: 1 band saw 32", 1 resaw, 8 rip and cut-off saws, 1 trim-saw double end; Sawmill: 1 O-Frick mill with power unit and edger; Tractors: 2 wheel tractors, 1 crawler and terrace grader; Water system: 2 emergency jet pumps with piping;

Together with all substitutions, renewals, replacements and additions, it being the intent and purpose hereof to mortgage each and every item used or useful now or hereafter in the Tryon Builders Supply Company's operations. Also all the stock on hand now or hereafter including lumber, finished and unfinished, felled timbers, builders supplies, and generally all goods, wares and merchandise, fixtures and stock, constituting the inventory of the Tryon Builders Supply Company at all times, together with accounts and all replenishments of the inventory of stock in trade.

The mortgagor, Tryon Builders Supply Company, shall have the right to sell in the regular course of business, but not otherwise, all lumber, building supplies, goods and stock which is customarily sold by it in the usual course of business, free from the lien of this mortgage, and the lien of this mortgage shall attach to lumber, building supplies, goods and stock which may be hereafter acquired or purchased and added to such business to replace the personal property sold, from time to time, in the regular course of business.

As to the personal property, the mortgagee or the holder hereof on default or attempt to remove said chattels out of its reach or knowledge may seize and take possession of said personal property first giving three days notice in writing on the bulletin board at Spartanburg Court House and apply the proceeds to the mortgage debt, or at the option of the holder, the mortgage as to the personal property in equity along with the mortgage of the real estate included herein.

This mortgage deed is a companion to a certain deed of trust of even date herewith executed by Tryon Builders Supply Company to J. T. Arledge, Trustee for Tryon Bank & Trust Company on certain property situate in Polk County, North Carolina and said two instruments together secure the aforesaid indebtedness.

This mortgage deed is a junior lien and subordinate to a certain mortgage deed executed by Tryon Builders Supply Company to Tryon Bank & Trust Company in the amount of \$25,500.00, dated the 11th day of May, 1957, recorded in Vol. 458, Page 148, Office of R.M.C. for Spartanburg County, South Carolina, and also recorded in Book 713, Page 426, in the office of R.M.C. for Greenville County, South Carolina.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises unto the said Tryon Bank & Trust Company, its ^{Successors} ~~XXXX~~ and Assigns forever.
