(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Thousand and No/100----- DOLLARS (\$15,000.00), with interest thereon from date at the rate of Five & One-Fourth per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Paris Mountain Township, on the northern side of Lake Circle, containing 19.07 acres, more or less, and according to a survey made by R. E. Dalton in May 1924, is described as follows:

BEGINNING at a stake, the corner of lots # 31 and 32 of Section "C" plat of June 1920, of Fitzpatrick Terry, and running thence N. 10 W. 115 feet; thence N. 22-48 W. 224.5 feet; thence N. 26 E. 168 feet; thence N. 57-30 E. 80.8 feet; thence N. 52-40 E. 142 feet; thence N. 72-05 E. 140 feet; thence N. 34 E. 130 feet; thence N. 5-40 W. 300 feet; thence N. 42-05 W. 300 feet; thence N. 70 W. 131.5 feet; thence N. 42-30 W. 402.3 feet to a large poplar tree near branch; thence S. 49-40 W. 354 feet to a stake; thence S. 21-20 E. 468 feet to a stake; thence S. 4-15 W. 1058 feet to Lake Circle Road; thence with Lake Circle Road, N. 60-20 E. 83 feet; thence N. 68 E. 200 feet; thence S. 87-40 E. 190.5 feet to the point of beginning.

Being the same premises conveyed to the mortgagor by deed recorded in Book of Deeds 308 at Page 121.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
