TO ALL WHOM THESE PRESENTS MAY CONCERN:

**EUNICE BARBREY AND ETHEL BARBREY (same as Ethel Barbrey Miller)**  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Six Thousand and No/100** -----

**DOLLARS (\$ 6000.00** ), with interest thereon from date at the rate of **five & three-fourths** (5 3/4%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in **Greenville Township, on the eastern side of Franklin Road, in Section known as Sans Souci, being shown as Lot No. 1 on plat of property of Vivian Q. Guion, recorded in Plat Book C at Page 131, and also shown as a portion of Lot 16 on plat of Sans Souci Villa recorded in Plat Book A, Page 510, and described as follows:**

**BEGINNING at an iron pin on the eastern side of Franklin Road at a point 112 feet north from the northeast corner of the intersection of Young Street and Franklin Road, and running thence in a line parallel with Young Street S. 57-25 E. 160 feet 8 inches to iron pin in line of Lot 4; thence N. 27-30 E. 56 feet 2 inches to iron pin; thence N. 57-25 W. 156 feet to pin on the east side of Franklin Road; thence along the east side of Franklin Road S. 32-35 W. 56 feet to the point of beginning.**

Being the same property conveyed to the mortgagors by deed recorded in Deed Book 530, Page 425.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
