

To All Whom These Presents May Concern:

hereinafter called

the Mortgagor(s), SEND GREETING:

WHEREAS, the said Mortgagor(s) in and by these Presents, well and truly indebted to

my certain promissory note in writing, of even date with E.H.Edwards

hereinafter called Mortgagee, in the full and just sum of DOLLARS, to be paid March, 1st., 1959

with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

E.H.Edwards, and his heirs and assigns forever, All parcel or lot of land, with all improvements thereon, situated on the North side of West Poinsett Street (formerly National nighway) in the City of Greer, said State and Countym Chick Springs Township, designated as Lot No.5 of K.L. Ford Property, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on North side of West Pointsett Street.corner of lots 5 and 6 and running thence along the line of same

Street, corner of lots 5 and 6 and running thence along the line of same N.27 E.1812 feet to iron pin in line of lot No.7; thence along line of lot No.7 5.87-50 %.70 feet to iron pin, corner of lot No.4; thence along the line of lot No.4, 5.8-27 w.1812 feet to iron pin on edge of west roinsett Street; thence along west roinsett Street N.87.50 E.70 feet to the beginning corner, and being all of the same lot of land conveyed to me by aximumath J. Frank Jones by deed dated 23rd., of April 1955 by deed recorded in the Uffice of R.M.C. for Greenville County in Deed Book Vol., 524, at page 47.
