WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-five Hundred and No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, designated as Lot 2 on plat of property of R. C. Ayers made by C. O. Riddle, November, 1957, containing 1.95 acres, and being more particularly described as follows:

BEGINNING at an iron pin in the center of S. C. State Highway No. 14 at the joint corner of Tracts 2 and 3 and running thence with the line of Tract 3 N. 77-49 E. 561.5 feet to pin in line of property of Joe Maxwell; thence with the line of Maxwell property N. 9-20 W. 124.6 feet to an iron pin; thence with the line of Lot 1 S. 83-37 W. 551. feet to point in center of S. C. Highway 14; thence with center of said highway S. 6-0 E. 181.3 feet to the point of beginning.
