(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand Five Hundred and no/100-----

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 9, as shown on plat prepared by R. K. Campbell, dated December, 1956, entitled "Forestdale Heights", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book KK at page 193, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the northern side of Forestdale Drive at the joint front corner of Lots Nos. 8 and 9, and running thence with the line of Lot No. 8, N. 4-31 E. 200 feet to an iron pin; thence S. 85-29 E. 70 feet to an iron pin at the joint rear corner of Lots Nos. 9 and 10; thence with the line of Lot No. 10, S. 4-31 W. 200 feet to an iron pin on the northern side of Forestdale Drive; thence with the northern side of Forestdale Drive, N. 85-29 W. 70 feet to the point of beginning.
