## MORTGAGE

State of South Carolina

COUNTY OF Greenville

TO ALL WHOM THESE PRESENTS MAY CONCERN: **We, Richard M. Staggs and  
Lillian T. Staggs,**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

**Five Hundred -----**

DOLLARS (\$ 500.00 ), with interest thereon from date at the rate of **Six (6%)**

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the east side of State Highway No. 14 near Washington Baptist Church, about four miles northward from the City of Greer, containing three acres, more or less, and having the following courses and distances, to-wit:

BEGINNING on a nail and stopper in the northern edge of the surfacing of the said highway No. 14, joint corner of the parsonage lot, and runs thence with the parsonage lot line, N. 45-30 E. 132 feet to an iron pin on the original line of Tessie Tapp and the line of Mrs. Bright; thence with the line, S. 75-35 E. 586 feet to an iron pin on the said line, new corner; thence S. 61-00 W. 528 feet to a point in the said highway No. 14; stake or iron pin at 476.5 feet on the northern bank of road; thence with the said road, N. 32-20 W. 368 feet to the beginning corner.

This is the same property conveyed to Richard M. Staggs and Lillian T. Staggs by deed of Tessie Tapp recorded in Vol. 322, page 103, R.M.C. Office for Greenville County, LESS, however, a small strip conveyed to the parsonage property of the Washington Baptist Church.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
