WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 9,000.00), with interest thereon from ~~date~~ September 12, 1958 at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the Eastern side of Knox Street, near the City of Greenville, being shown as lot # 50 and one-half of lot # 51, on a plat of Glendale Heights, recorded in Plat Book KK at Page 143, and described as follows:

BEGINNING at a stake on the Eastern side of Knox Street, at the corner of lot # 49, and running thence with the line of said lot, N. 43-15 E. 130 feet to a stake, corner of lot # 46; thence N. 6-45 W. 105 feet to a stake in the center of lot # 51; thence S. 83-15 W. 130 feet to a stake on Knox Street; thence with the Eastern side of said Street, S. 6-45 E. 105 feet to the point of beginning.
