C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of TWELVE THOUSAND AND NO/100-----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot 250 of Section 3, Belle Meade, recorded in Plat Book GG at page 187 and having the following metes and bounds:

BEGINNING at an iron pin on the Northeast side of Marlboro Drive, joint front corner of Lots 250 and 251, and running thence with the line of Lot 251, N. 55-0 E. 139 feet; thence N. 35-05 W. 121.9 feet to an iron pin in line of Lot 187; thence with the line of lots 187 and 188, S. 61-42 W. 140 feet to an iron pin on Marlboro Drive; thence with said Marlboro Drive, S. 35-00 E. 132.3 feet to the point of beginning.
