All those lots of land in the State of South Carolina, County of Greenville, on the southern side of Springdale Avenue, in the City of Greer, being shown as Lots 72 and 73 on a plat of property of N. M. Cannon recorded in Plat Book F, Page 199, and described as follows:

BEGINNING at a stake on the southern side of Springdale Avenue 300.5 feet west from South Main Street at the corner of Lot 71 and running thence with the line of said lot S. 13-00 E. 165.7 feet to an iron pin; thence S. 77-00 W. 100 feet to an iron pin at the corner of Lot 74; thence with the line of said lot N. 13-00 W. 166.7 feet to an iron pin on Springdale Avenue; thence with the southern side of said avenue N. 76-45 E. 100 feet to the beginning corner.
