"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Pine Street, near the City of Greenville, known and designated as lot # 3, Section H, on a plat of Woodwille Heights, recorded in Plat Book L at Pages 14 and 15, and being more particularly described according to a recent survey prepared by R. W. Dalton in September 1956, as follows:

"BEGINNING at an iron pin on the Western side of Pine Street, which pin is 121.5 feet Southwest of the curve of the intersection of said street, with Alice Street, and running thence with line of lot # 2, Section H, N. 54-15 W. 330.6 feet to an iron pin in a branch at the rear corner of lot # 3A and running thence with the branch as the line and the rear line of lot # 3A, S. 21-51 W. 106.4 feet to an iron pin, rear corner of lot # 4; thence with the line of said lot, S. 54-15 E. 304 feet to an iron pin, on the Western side of Pine Street; thence with the Western side of Pine Street, N. 36-20 E. 103 feet to an iron pin, the point of beginning."
