(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ninety-seven Hundred and No/100 -----

DOLLARS (\$ 9700.00), with interest thereon from date at the rate of five & one-half (5½%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the east side of Bennett Street in the City of Greenville, being shown as Lot No. 1 on a plat of the property of Central Realty Corporation prepared by Dalton & Neves, September 1946, and recorded in Plat Book Q at Page 5, and according to said plat, having the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Bennett Street, corner of Lot 2; running thence with the line of said lot S. 71 E. 143.8 feet to an iron pin in the rear line of Lot 36 of North Hills Subdivision; thence with the line of said lot N. 19-17 E. 69 feet to an iron pin at the rear corner of Lot 118 of North Hills Subdivision; thence with the line of said lot N. 71 W. 143.8 feet to an iron pin on the east side of Bennett Street; thence with the east side of said street S. 19-17 W. 69 feet to the beginning corner.

Being the same property conveyed to the mortgagors by deed of Bill B. Bozeman dated December 23, 1958.
