TO ALL WHOM THESE PRESENTS MAY CONCERN:

CHARLES P. MCINTYRE AND MILDRED G. MCINTYRE of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto GENERAL MORTGAGE CO.

organized and existing under the laws of South Carolina, a corporation
hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of Eight Thousand Five Hundred Fifty
Dollars (\$8,550.00), with interest from date at the rate of five and one fourth per centum
(5 1/4 %) per annum until paid, said principal and interest being payable at the office of
General Mortgage Co. in Greenville, South Carolina,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Fifty-one and 30/100ths----- Dollars (\$ 51.30),
commencing on the first day of February, 19 59, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of January, 19 84.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land situate, lying and being on the
Southwestern side of Cottingham Street, near Monaghan Mills in the County
of Greenville, State of South Carolina, and known and designated as Lot
No. 45 as shown on a plat entitled "Monaghan Subdivision, Greenville,
S.C.", made by Piedmont Engineering Service, Greenville, S.C., August
9, 1954, recorded in the R.M.C. Office for Greenville County in Plat
Book GG at pages 86 and 87, and having according to said plat and also
according to a more recent plat prepared by Piedmont Engineering Service,
dated November 25, 1958, entitled "Property of Charles P. McIntyre &
Mildred G. McIntyre", the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Cottingham Street at
the joint front corner of Lots Nos. 44 and 45, and running thence with
the line of Lot No. 44 S. 48-03 W. 184 feet to an iron pin; thence
S. 51-32 E. 90 feet to an iron pin at the joint rear corner of Lots Nos.
45 and 46; thence with the line of Lot No. 46 N. 41-56 E. 177.6 feet to
an iron pin on the Southwestern side of Cottingham Street; thence with
the Southwestern side of Cottingham Street N. 48-04 W. 70 feet to the
point of beginning.

in the R.M.C. Office for Greenville County, South Carolina.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-

had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and
assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple
absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
