WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Five Hundred and No/100----- DOLLARS (\$5500.00), with interest thereon from date at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in the City of Greenville, on the eastern side of North Leach Street, and being described as follows:

BEGINNING at an iron pin on the Eastern side of North Leach Street, at the corner of a 20-foot alley and North Leach Street, and running along said 20-foot alley, S. 71 1/4 E. 125 feet to pin; thence approximately parallel with North Leach Street, N. 18 3/4 E. 48 feet to pin; thence parallel with the first mentioned line, N. 71 1/4 W. 125 feet to pin on Leach Street; thence with the Eastern side of Leach Street, S. 17 3/4 W. 48 feet to the beginning corner.
