### MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Fred E. Hudson,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township,  
on the south side of the Bennett's Bridge Road near Enoree River,  
containing 11.27 acres, more or less, being the same property conveyed to Fred E. Hudson by deed of John E. Hudson recorded in Deed Book 465, page 36, R.M.C. Office for Greenville County, LESS, therefrom, one acres, more or less, conveyed to David Brannon.
