"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Fairview Township, a short distance South of the Town of Simpsonville, being lot # 2 on plat by C. O. Riddle, Surveyor, January 23, 1958. It begins in the center of the C. & W. C. Railroad tracks at joint corner of lot # 1 and lot # 2 and runs thence along the joint line of these two lots North 77-53 West for 351.9 feet which said line crosses the right of way of the C. & W. C. Railroad and the old Laurens Road (otherwise known as the Fairview Road) to point on lands of the estate of Bruce H. Richardson which is the Southwestern corner of lot # 1 on the plat; thence through the Bruch H. Richardson estate lands South 8-45 West 100 feet to iron pin on lands of the estate of Bruce H. Richardson; thence cutting through the Bruce H. Richardson estate lands and running South 77-53 East 363 feet crossing the old Laurens Road, the right of way of the C. & W. C.
