, with interest thereon from date
at the rate of 6 per centum per annum, to be computed and paid monthly
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

gained, sold and released, and by these Presents do grant, bargain, sell and release unto the said
W. A. Hopkins and his heirs and assigned for ever:

All that piece, or lot of land with improvements thereon in Oaklawn Township,
Greenville County, State of South Carolina, being part of the home place of
C. C. Wilson, containing one (1.00) acre, more or less, as shown by a survey
made by W. F. Adkins, March 25, 1940, said lands has the following metes and
bounds to wit:

BEGINNING at a corner, joint corner of C. C. Wilson land and this lot, in the road,
running thence with C. C. Wilson line, S. 44 1/2 W. 2.16 chains to a stake; thence
continuing with C.C. Wilson line S. 36 E. 6.70 chains to a stake; thence S. 79 1/2
E. 56 links to a stone, T. D. Bennett corner; thence with Bennett line N. 22 3/4
W. 6.77 chains to road; thence N. 60 W. 75 links to the beginning corner.
