NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Northeast side of Parker Road in Greenville Township, and being known and designated as Lot 27 on a plat of Junction Heights, recorded in Plat Book C at page 106, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeast side of Parker Road at the joint front corner of Lots 27 and 28 and running thence with the line of Lot 28, N. 62-30 E. 150 feet to a pin in line of Lot 29; thence with the line of Lot 29, S. 37-06 E. 50 feet to an iron pin at rear corner of Lot 26; thence with the line of Lot 26, S. 62-30 W. 150 feet to pin on Parker Road; thence with the North east side of Parker Road, N. 37-06 W. 50 feet to the Beginning.

Being the same conveyed to Mortgagor by deed recorded in Vol. 341 at page 361.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
