MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

EVELYN N. TINGLE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto T. Raymond Bellotte and Lena R. Bellotte (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand and No/100--

DOLLARS (\$10,000.00),

with interest thereon from date at the rate of ----- per centum per annum, said principal and interest to be repaid: ten (10) years from date, or upon title to the mortgaged premises becoming sooner vested in any other person in any manner, other than by death of the mortgagor; and the obligation herein secured is further to be deemed paid in full, and this instrument to be null and void, if the title to the said premises shall remain in the mortgagor at the expiration of ten (10) years from date

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

situate, lying and being in Butler Township and having according to a plat of the property of T. R. and Lena R. Bellotte, made by C.O. Riddle March 12, 1958, the following metes and bounds, and containing 7.35 acres, also being shown as tract 8.1, section 3, page 539, on County Block Book.

BEGINNING at a point in the center of county road, and running thence along the line of the property of T. R. and Lena R. Bellotte, S. 46-30 E. 851.4 feet to an iron pin in line of the property of Donald Riddle; thence along the line of the Riddle property, S. 46-35 W. 283.3 feet to an old iron pin; thence S. 49 W. 41.8 feet to old iron pin in line of property now or formerly owned by W. M. Eke; thence along the Pike property, N. 56-58 W. 803.7 feet to nail in center of county road; thence along the center line of said road the following courses and distances: N. 33-59 E. 119.4 feet to point; thence continuing N. 40-07 E. 354.3 feet to point in center of road, point of beginning.

Being the same property conveyed to Evelyn N. Tingle by deed recorded in Book of Deeds 597 at Page 70.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
