C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight Thousand Two Hundred and No/100ths

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northeastern side of Bayne Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 19 as shown on a revised plat of View Point Place, prepared by C.C. Jones, dated June and September, 1952, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book CC at page 152, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Bayne Drive at the joint front corner of Lots Nos. 18 and 19, and running thence with the line of Lot No. 18 N. 46-50 E. 174.9 feet to an iron pin in the line of property now or formerly of Tom Robinson; thence with the line of the said Robinson property N. 49-10 W. 70.5 feet to an iron pin at the joint rear corner of Lots Nos. 19 and 20; thence with the line of Lot No. 20 S. 46-50 W. 167.6 feet to an iron pin on the Northeastern side of Bayne Drive; thence with the Northeastern side of Bayne Drive S. 43-10 E. 70 feet to the point of beginning.
