"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Gantt Township, near Conestee, S. C., on the Southwestern side of a county road which leads from the Parkins Mill Road to the Conestee-Mauldin Road, and having the following metes and bounds:

BEGINNING at an iron pin on the boundary line of Conestee Lake, corner of property now or formerly of R. C. Willimon, and running thence with the line of said property, N. 61-15 E. 365.5 feet to the center line of the above mentioned county road; thence with the center line of said road, S. 27-02 E. 156.6 feet to a point, front corner of property now or formerly of Calvin Fowler; thence with the line of said property, S. 61-15 W. 394.9 feet to boundary of Conestee Lake; thence with said Lake as the line, N. 18-07 W. 159.3 feet to the beginning corner.
