TO ALL WHOM THESE PRESENTS MAY CONCERN:

BEVERLY ANN B. FINLEY (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand and no/100-----

DOLLARS (\$ 5,000.00), with interest thereon from date at the rate of Six (6%)

per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Western side of Oakland Drive in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2, as shown on a plat prepared by C. O. Riddle, dated December 31, 1954, entitled "Property of Fannie K. Elledge", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book II at page 23, and having according to said plat the following metes and bounds:

BEGINNING at a point in Oakland Drive, which point is located S. 10-19 E. 176.2 feet from an iron pin at the intersection of Lowndes Hill Road and Oakland Drive, and running thence S. 10-19 E. 100 feet to an iron pin in the edge of Oakland Drive; thence with the line of property now or formerly of Henderson S. 49-53 W. 120 feet to an iron pin; thence with the line of property now or formerly of Batson N. 19-02 W. 153.4 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence with the line of Lot No. 1 N. 76-03 E. 127.7 feet to the point of beginning (passing through an iron pin 6.4 feet from the beginning corner).
