TO ALL WHOM THESE PRESENTS MAY CONCERN: I, W. Kenneth Burgess,

Greer, S.C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

All that certain parcel or lot of land situated on the north side of Memorial Drive Extension near the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 2 of the W. Dennis Smith Property according to survey and plat by H.S. Brockman, Registered Surveyor, dated April 5, 1955, recorded in Plat Book FF, page 294, R.M.C. Office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
