M. C. Office for Greenville County in Plat Book "EE", at Page 108 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwest corner of the intersection of Augusta Road and North Wingate Road and running thence along the western side of said Augusta Road S. 14-12 W. 120 feet to an iron pin; thence along the joint line of Lots Nos. 9 and 10 N. 75-48 W. 125 feet to an iron pin; thence along the side line of Lot No. 8 N. 14-12 E. 120 feet to an iron pin; thence along the southern side of North Wingate Road S. 75-48 E. 125 feet to the point of beginning.
