of **Greenville, South Carolina**, hereinafter called the Mortgagor, send(s) greetings:

All that piece, parcel or lot of land, situate, lying on the North East side of Tiffany Drive near the City of Greenville in the County of Greenville State of South Carolina, and known and designated as Lot #45, Block D of Sub-Division known as Mayfair Estates, Plat of which is recorded in the R.M.C. office for Greenville County in Flat Book S at page 72 and 73. Said lot having such notes and bounds as shown thereon.
