We, Annie May Dean and Leonard Dean

SEND GREETING:

Whereas, we, the said Annie May Dean and Leonard Dean  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to B.P. Edwards  
in the full and just sum of Six hundred eighty-one and 33/100  
(681.33)- - - -, to be paid \$25.00 per month for 23 months, all to be due  
and paid in full in 24 months, from date hereof--

, with interest thereon from maturity  
at the rate of ~~SEVEN~~ per centum per annum, to be computed and paid annually from maturity  
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
