WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand and no/100-----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as Lot No. 27, as shown on a plat prepared by C. C. Jones & Associates, Engineers, dated April, 1955, entitled "Sharon Park", and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book EE at page 175, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northwestern side of Derwood Lane at the joint front corner of Lots Nos. 26 and 27 and running thence with the line of Lot No. 26 N. 33-29 W. 228.4 feet to an iron pin in the rear line of Lot No. 20; thence with the line of Lot No. 20 S. 64-53 W. 30 feet to an iron pin at the joint rear corner of Lots Nos. 27 and 28; thence with the line of Lot No. 28 S. 0-11 E. 220 feet to an iron pin on the northwestern side of Derwood Lane; thence with the curve of the northwestern side of Derwood Lane the following chords and distances; S. 83-22 E. 10 feet to an iron pin, N. 81-41 E. 75 feet to an iron pin, N. 65-25 E. 75 feet to the point of beginning.
