WHEREAS, the Mortgagor is well and truly indebted unto AIKEN LOAN & SECURITY COMPANY

and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that lot of land in the county of Greenville, state of South Carolina, known
and designated as Lot No. 17 on plat of J. E. Harmon recorded in plat book L page
153 of the RMC Office for Greenville County, S. C., said lot having a frontage of 75
feet on the north side of Westbrook Drive, a depth of 205.85 feet on the west side,
a depth of 205.8 feet on the east side, and a rear width of 75 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.
