WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirteen Thousand and No/100 ------

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, situate on the northern side of Pemberton Drive and being shown and designated as Lot 17 on plat of Mont Royal Heights recorded in Plat Book KK, Page 111, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Pemberton Drive at joint front corner of Lots 17 and 18 and running thence with the line of Lot 18 N. 1-50 E. 236.6 feet to pin; thence N. 78-55 W. 130 feet to an iron pin at rear corner of Lot 16; thence with the line of Lot 16 S. 10-41 W. 267.feet to an iron pin on Pemberton Drive; thence with the northern side of Pemberton Drive S. 85-53 E. 85 feet to the pen; thence continuing with Pemberton Drive N. 85-25 E. 85 feet to the point of beginning.
