All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being on the northwesterly side of Hodgens Drive, near the
City of Greenville, S. C., and being shown as Lot No. 13 on the plat of the proper-
ty of Lela S. Hodgens as recorded in the RMC Office for Greenville County, S. C. in
Plat Book JJ, page 189, said lot fronting 85 feet on the northwesterly side of
Hodgens Drive, and having a depth of 133.9 feet on the northeasterly side, a depth
of 133.3 feet on the southwesterly side, and being 85 feet across the rear.
