Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

THE WESTERN AND SOUTHERN LIFE INSURANCE COMPANY

, a corporation organized and existing under the laws of STATE OF OHIO, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Three Hundred Fifty Dollars (\$11,350.00), with interest from date at the rate of five & one-fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of The Western and Southern Life Insurance Company in Asheville, North Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-eight and 10/100 ----- Dollars (\$68.10), commencing on the first day of May, 1959, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of April, 1984.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the southern side of Elmira Street near the City of Greenville, being shown as Lot No. 7 on a plat of Glenwood Acres recorded in Plat Book HH, Page 135, and described as follows:

BEGINNING at a stake on the southern side of Elmira Street 54.6 feet east from Trenholm Road at corner of Lot 6 and running thence with the southern side of Elmira Street N. 57-41 E. 30 feet and N. 64-36 E. 85 feet to an iron pin at the corner of Lot 8; thence with the line of said lot S. 25-24 E. 173.8 feet to a post; thence S. 60-51 W. 68.9 feet to an iron pin at the corner of Lot 6; thence with the line of said lot N. 40-07 W. 180.8 feet to the beginning corner.
